Weight of Snow



For those of you that are wondering “When should I shovel the snow off my roof?” Here is a quick rule to help you if you are concerned.

As a rule of thumb, snow weighs approximately 20 pounds per cubic foot or 1.25 pounds per inch of depth. Depending on moisture content, snow can weigh from 1 pound per cubic foot to over 21 pounds per cubic foot

Here is a formula to figure out what the snow on your home weighs:

$$S \times 1.25 = P$$

S = Height of snow in inches

1.25 = Weight of snow

P = Pounds per square foot

If the snow on your roof is 20 inches deep then

this is what the formula looks like:

$$20 \times 1.25 = 25$$

The snow weighs 25 pounds per cubic foot. NOTE: Any ice build-up on the roof would need to be added to this formula. Add 5.2 pounds for each 1 inch of ice depth.

Also:

- Structures constructed in Ashton with building permits are designed for 70 pounds per square foot roof snow load. Older roofs may be of concern because they were built before permits were required and may not meet this minimum roof snow load.
- Until recently, manufactured homes were designed for a roof snow load of 30 pounds per square foot. Look at the certification label (a metal label affixed to the manufactured home) to verify your design roof snow load.
- Flat roofs are more of a concern (Less than 3/12 pitch). Flatter roof

itches tend to hold more snow moisture.

- If we receive excessive rainfall, the weight of the roof snow can increase rapidly.
- If your structure is in question, it is best to consult an Idaho licensed engineer.

Please be aware of the potential dangers of shoveling or raking snow from a roof. Besides the potential damage to the roofing materials and structure, there are such factors as a person sliding off the roof, falling off a ladder, over-exerting themselves or injury from snow sliding on top of them.

In summary, the City of Ashton does not make recommendations on when to remove snow from roofs. It is up to the individual property owner to consider the benefits and dangers of snow removal and decide their own course of action.

Careful of the Water Meters

Each home or business on the City water system has a water meter. The water meters have a module on the top of the lid to help with electronic reading.

Customers will need to be cautious about parking, plowing or mowing around the meter lid in order to avoid damage to the meter.

Do not park or drive over the meters. While mowing, please make

sure that neither blade nor wheel damage to the meter or lid will occur. During the winter, plowing can also ruin the module if the lid is plowed over. Please mark your meter to avoid plowing over it, driving over it or any other winter activity that could damage the meter.

Please be cautious with the meter boxes and lids in order to avoid any extra charges.

FROZEN

In Ashton, the frost line or the depth that the groundwater in soil is expected to freeze is usually four feet. Snow cover can insulate the ground so that the frost depth is lessened but many residents move the snow in order to make parking easier which makes freezing easier. When the ground freezes, water lines can freeze also.

Moving water does not freeze as easily as standing water.


The City water mains are running much of the time but many homes may not have water moving through their service lines at all times. This is where running a dripping faucet may help.

Letting the cold water in a faucet drip can prevent frozen service lines. The drip can be very slight and can be adjusted depending on the weather forecast. If the weather forecast calls for colder weather, the faucet should be

adjusted to a larger drip.

Since the frost depth is deeper with each below freezing day, it may be necessary to continue to let a faucet drip until spring arrives.

The City encourages residents to use their own judgment in deciding when to run a drip to prevent frozen water lines.



PARKING AND SNOW

Greetings and happy New Year. I would like to remind residents to park your vehicles as far off the City street right of way as possible for plowing purposes. The street crew spends a lot of time and effort to clear our streets so let's make it as easy as possible for them. This winter the snow is deep so the plow crew requires more of the City street right of way to push snow back. Remember to remove your garbage cans from the street, the plowing crew is not responsible for moving them for you.

This winter our department has received several complaints about residents pushing or blowing snow into the street and/or street right of way. When you do

this your snow is carried from your property by the City plow to your neighbor's driveway. There is an ordinance against this action and you can be prosecuted for the violation. Please be courteous.

Our department has also received complaints in reference to overnight and long term parking on Main Street. The City has an active ordinance that states that parking is limited to 2 hours between the hours of 8:00 am and 6:00 pm with no parking on Main Street between the hours of 2:00 am and 6:00 am. This is subject to a possible fine and/or towing of your vehicle if violated. If your vehicle is towed the tow and impound fees are your responsibility. Ashton has

limited parking and the Main Street business owners require the parking spaces for their customers. Remember, it is also a violation to park a vehicle on any City street right of way that interferes with snow removal at any time of the day OR night. You can be subject to a fine and towing of your vehicle for this violation.

The 100th anniversary of the American Dog Derby is February 16th thru the 18th so please come out and support this special event. The Derby is an important part of our town's history and there are activities for every age group. Please invite your family and friends to this historic weekend.

DOG LICENSE RENEWAL TIME IS HERE!


It is time to renew all City of Ashton dog licenses. Every dog in Ashton is required to be licensed. Licenses are sold at the City Building and cost \$7.50. Any dog owner who is known to have failed to license

their dog is subject to a minimum fine of \$25.00. (Ashton Code 6.08.20) **The 2017 Ashton dog license is blue and is the shape of a bell.**

Additionally, even if the dog is licensed, dogs are required to be on your property or on a leash of less than 10 feet. If not, the dog is considered running at large.

Any dog caught running at large is subject to impoundment by the City dog catcher.
