### CALL TO ORDER & WELCOME

**Mayor Stronks opened the meeting at 3:57 pm.**

### 1. EXECUTIVE SESSION:

*I.C. 74-206 Certain City-related matters may need to be discussed confidentially as a matter of law (Acquisition of real property, personnel matters, attorney-client communications) subject to applicable legal requirements, the Council may enter executive session by roll call vote to discuss such matters.*

(a) To consider hiring a public officer, employee, staff member or individual agent, wherein the respective qualities of individuals are to be evaluated in order to fill a particular vacancy or need. This paragraph does not apply to filling a vacancy in an elective office or deliberations about staffing needs in general;

Mayor Stronks explained that the City Council would be conducting job interviews in Executive Session. Councilwoman Harrigfeld was not in attendance at the beginning of the meeting. She arrived at approx. 4:15 pm.

Councilman Atchley made a motion to enter an executive session per Idaho Code section 74-206 (a).

Councilman Funke seconded the motion. A roll call vote was taken: Funke, aye; Atchley, aye; Hansen, aye.

The motion passed unanimously.

Mayor Stronks excused the City Clerk Stegelmeier who will be bringing the candidates to the Council Chamber one at a time. Todd Martindale attended the session. The Council entered executive session at 4:00 pm.

Councilman Atchley made a motion to exit executive session. Councilwoman Harrigfeld seconded the motion.

A roll call vote was taken. A roll call vote was taken: Funke, aye; Atchley, aye; Hansen, aye; Harrigfeld, aye.

The motion carried unanimously.

The Council exited Executive Session at 5:47 pm.
